Based on R.A 9184 there is a circular issued by the GPPB re: Guidelines on the Use of Non-Discretionary/Non-Discriminatory Selection criteria as Tie-Breaking Method in Case of Two or More Bidders are Determined and Declared as the Lowest Calculated and Responsive Bidder (LCRB) or Highest Rated and Responsive Bidder (HRRB). The bidders agreed to break the tie through toss coin. Thereafter, the BAC invited them the following week to witness the toss coin performed by one of the members of the BAC. The RILEM PHARMA CORPORATION and MED ALERT was declared as the winning bidders.


IV. ADJOURNMENT


