

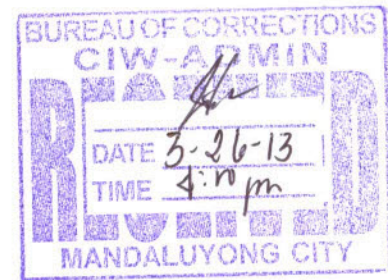

Returned to Officer-in-Charge Rafael Marcos Z. Ragos, Bureau of Corrections, Muntinlupa City, **hereby APPROVING**, the enclosed Memorandum of Agreement between the Correctional Institution for Women (CIW) and Mang Kiko Catering Services for food catering services for the inmates at the Correctional Institution for Women for a period of six (6) months commencing from **February 1, 2013 to July 31, 2013** in the amount of forty nine pesos and forty centavos (P49.40) per day per inmate, subject to the availability of funds and the usual accounting and auditing requirements.

The Extension of Contract for Emergency Catering Services entered into by the Correctional Institution for Women (CIW) for the period February 1-28, 2013 is **deemed automatically terminated** in accordance with this Department's 2nd Indorsement dated 19 November 2012, portion of which reads:

“However, in order not to disrupt the efficient and effective delivery of service by the CIW, and considering the urgency of the situation, the CIW is hereby directed to immediately negotiate with a technically, legally and financially capable supplier/caterer in accordance with the rules on Negotiated Procurement (Emergency cases) under Section 53.2 of the RIRR of R.A. No. 9184.

*It is understood that the negotiated contract shall only be effective while the CIW is still conducting a re-bidding and **shall automatically terminate when the contract, awarded by the CIW pursuant to the re-bidding, is approved by this Department.** However, the negotiated contract shall not exceed three (3) months.”*




