2. The *BUREAU OF CORRECTIONS - Sablayan Prison and Penal Farm* now invites bids for the SUPPLY AND DELIVERY OF FUELS AND LUBRICANTS FOR SPPF VEHICLES AND EQUIPMENTS FOR THE PERIOD OF JANUARY TO DECEMBER 2016. Delivery period shall be within 10 (Ten) calendar days upon receipt of Notice to Proceed
3. Bidders should have completed, within 2 (two) years from the date of submission and receipt of bids, a single contract similar to the Project equivalent to Fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. The complete set of Bidding Documents may be downloaded free of charge from the website of The Philippine Government Electronic Procurement System (PhilGeps) and may be purchased by the interested bidder upon payment of a **non-refundable fee of PhP5,000.00** at the bids and awards office.
