2. **ANNUAL INCOME TAX RETURN AND CASH FLOW STATEMENT** SHALL BE ADDED IN CLAUSE 12.1 NO. 5 OF BID DATA SHEET (BDS).
3. BANK DRAFT/GUARANTEE OR IRREVOCABLE LETTER OF CREDIT ISSUED BY A UNIVERSAL OR COMMERCIAL BANK WILL BE **OMITTED** AS PART OF BID SECURITY UNDER CLAUSE 18.1 OF BID DATA SHEET.

**FURTHERMORE**, LETTER OF AUTHORITY SHALL BE ATTACHED IN ITS SECRETARY'S CERTIFICATE.

**MOREOVER**, ON BID SECURING DECLARATION AND CERTIFICATION AS TO COMPLIANCE OF EXISTING LABOR LAWS AND STANDARDS, "AFFIANT" SHALL BE AMENDED TO **SIGNATURE OVER PRINTED NAME OF AUTHORIZED REPRESENTATIVE** AND **ANNEX D SHALL BE OMITTED**.
