## INVITATION TO BID

1. The **Bureau of Corrections** through the **General Appropriations Act** intends to apply the sum of One Million One Thousand Eight Hundred Seventeen & 03/100( **P1,001,817.03**)being the Approved Budget for the Contract (ABC) to payments under the contract for the **REPAIR /RENOVATION OF INFIRMARY SECTION, MSC – BUREAU OF CORRECTIONS**. Bids received in excess of the ABC shall be automatically rejected at bid opening
2. The **BUREAU OF CORRECTIONS** now invites Contractors with valid and current Philippine Contractor Accreditation Board (PCAB) Minimum Range of Small B and License Category C (*The PCAB license must indicate PCAB registered contractor for Government Projects*) to bid for **REPAIR /RENOVATION OF INFIRMARY SECTION, MSC – BUREAU OF CORRECTIONS**. Completion of the Works is required **within 45 calendar days upon receipt of Notice to Proceed**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.
3. Prospective Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, at least one (1) single contract similar to the Project amounting to **at least fifty percent (50%)** of the ABC to be supported by Constructors Certificate of Performance Evaluation System (CPES) Rating Sheet which must have a Satisfactory Rating or Owner's Certificate of Acceptance. For purpose of this project similar contract shall refer contract involving building constructions
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. The Invitation to Bid and Checklist of Requirement may be downloaded from the website of The Philippine Government Electronic Procurement System (PhilGeps) and BuCor website [www.bucor.gov.ph](http://www.bucor.gov.ph). The complete set of Bidding Documents may be purchased by the interested bidder upon payment of a **non refundable fee of P5,000.00**

For purposes of having legal personality to either attend the Pre-Bid conference and /or to raise or submit written queries or clarifications relative to this bid project, Bidders must first pay the non refundable fee for the Bidding Documents


7. Interested bidders may obtain further information from Logistics Division c/o Larry A. Hari or Albern B. Alcantara and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 p.m.

However, any queries relative to the contents of the bid documents and the project requirements can only be made by the bidders who purchased the bid documents **not later than ten (10) days prior to the submission of Eligibility documents, Technical documents and Financial proposals.**
