**SUPPLY & DELIVERY OF VARIOUS MEDICINES AT NEW BILIBID PRISON HOSPITAL (NBPH),
RECEPTION & DIAGNOSTIC CENTER (RDC) AND CORRECTIONAL INSTITUTION FOR WOMEN (CIW)
FOR 1ST & 2ND QUARTER 2015 (REBID)**

1. The *BUREAU OF CORRECTIONS*, through its Bids and Awards Committee, intend to apply the sum of **EIGHT MILLION SEVEN HUNDRED FORTY NINE THOUSAND TWO HUNDRED EIGHTY TWO PESOS & 80/100 (P 8,749,282.80)** being the Approved Budget for the Contract (ABC) for the SUPPLY & DELIVERY OF VARIOUS MEDICINES AT NEW BILIBID PRISON (NBPH), RECEPTION & DIAGNOSTIC CENTER (RDC) & CORRECTIONAL INSTITUTION FOR WOMEN (CIW) FOR 1st & 2nd QUARTER OF 2015 (REBID). The interested bidders have the option to bid for any line item provided that it will not exceed their respective ABC (Approved Budget for the Contract). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *BUREAU OF CORRECTIONS* now invites eligible bidders with LICENSE TO OPERATE (LTO) from FOOD AND DRUGS ADMINISTRATION (FDA) as manufacturer, distributor, wholesaler, importer or trader of drugs / medicine.
3. Bidders should have completed within 2 (two) years from the date of submission and receipt of bids, a contract similar to the project amounting to at least twenty five percent (25 %) of the Approved Budget of the Contract . Completion of Delivery is twenty (20) calendar days upon receipt of Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The Pre-Bid Conference shall be open only to all interested parties who have purchased the Bidding Documents to have a legal personality to raise or submit written queries or clarification in the Conference. Bidders are encouraged to send their authorized technical representative or personnel who are familiar with the bid requirements and will prepare the documents for the bidder
