PLACEMENT COMMITTEE RA 10575
RESOLUTION NO. 002-2017

WHEREAS, the Placement Committee of RA 10575 convened on December 7, 2017 at the New Conference Room, Bucor Administration Building, NBP Reservation Muntinlupa City at about 11:00AM ;

WHEREAS, the Committee upon considering the issues that arised during the presentation of the matrix on the results of the individual scores of incumbent custodial personnel guided by the previously approved criteria, the Committee agreed to make an addendum to the Resolution No. 001 – 2017 relative to the placement of incumbent custodial personnel to the approved Indicative Staffing Pattern (ISP).

WHEREAS, in order to address the issues at hand, the Committee agreed to apply the bracketing system as follows:

BRACKETING SYSTEM:

PLANTILLA (FROM)	ISP (TO)
PS I & PS II	Corrections Senior Superintendent to Corrections Chief Superintendent
SO III & PIS	Corrections Superintendent to Corrections Senior Superintendent
SO I & SO II	Corrections Chief Inspector to Corrections Superintendent
PG III	Corrections Senior Inspector to Corrections Chief Inspector
PG II	Corrections Inspector to Corrections Senior Inspector
PG I	Corrections Officer I to Corrections Inspector

WHEREAS, those who got the highest scores under the Bracketing System will be prioritized in the placement to the next higher Corrections Officer (CO) ranks;

WHEREAS, in case of tie in the Bracketing System, the Committee also agreed to consider the following in the order of priority: 1) present position (with the date designated); 2) date started in the service; and 3) age;

WHEREFORE, premises considered, the Committee RESOLVES as it is hereby RESOLVED to recommend to the Officer-In-Charge Bureau of Corrections the approval of the above Bracketing System for the Placement of incumbent custodial personnel to the Indicative Staffing Pattern (ISP), pursuant to Republic Act 10575.
