- Bidders shall provide correct and accurate information required in this form.
- Price quotation must be valid for a period of One Hundred Twenty (120) calendar days from the date of submission.
- Price quotation/s, to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.
- Quotations exceeding the Approved Budget for the ABC shall be rejected.
- Award of contract shall be made to the lowest quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specification and terms and conditions stated herein.
- Any alterations, erasures or overwriting shall be valid only if they are signed or initiated by you or any of your duly authorized representative/s.
- The item/s shall be delivered within fifteen (15) calendar days from receipt of approved purchase order/Notice to Proceed.
- The San Ramon Prison and Penal Farm shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. The San Ramon Prison and Penal Farm, shall rescind the contract once the cumulative amount damages reach ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
- Bidders shall submit other **LEGAL TECHNICAL AND FINANCIAL** documents as may be required by the BAC once declared the **LOWEST CALCULATED QUOTATION (LCQ)**.
- Late submission of RFQ shall not be accepted.


