I, _____, Prison No. _____, an inmate student, hereby promise to abide by the Rules and Regulations mandated by the Bureau of Corrections and this unit, _____.

That I will do the following to maintain my privilege as an inmate student:

1. Maintain respect and courtesy to teachers, co-students, co-directives, visitors and BuCor Officials at all times;
2. Obliterate my gang mark and inhibit myself from joining or taking part in any gang activity;
3. Maintain a grade not lower than 75% in all my subjects and general average of not lower than 80%;
4. Study hard and will not find reason to justify my cause of low grades nor failure/s. Three failures in any of my subjects shall mean expulsion from this unit;
5. Must attend at all times the subjects and activities of the school and should come to school 15 minutes before the schedule time of class/activities. Three (3) to five (5) times consecutive unauthorized absences, and/or (5-7) consecutive unreasonable tardiness shall be ground for disciplinary action and/or cancellation of my Directive;
6. Go to class well-groomed, wearing prescribed uniform/descent dress and identification card;
7. Must attend punctually all school functions, emergency meetings, duties, special assignments and others. Any interruption of classes is strictly prohibited, unless schedule request is advised and approved by the higher authority;
8. Involvement in any contraband such as prohibited drugs, alcohol, cell phone and alike and/or any activities such as abandoning of classes without authorization, cheating during classes or examination period, stealing, gambling, vandalism, quarreling/fighting, selling school and government properties, malicious mischief or damage to property intentional or unintentional, rumors mongering, and involvement in any illegal monetary transaction shall be ground for disciplinary actions and/or cancellation of my Directive;
9. Abide and enjoined to cooperate with my instructors to finish all requirements assigned by my instructors/instructress/teachers at any given period. Non-compliance will result to either be Incomplete or not be included in the graduation;
10. Attended my visitors only during off classes or break hours and to the prescribed visiting shed;

11. Be present at the spiritual fellowship and morning exercises;
12. Comply with the student's clearance as requirement upon enrollment. No promissory notes and alike will be entertained and be given consideration prior to clearance; and
13. Consider education program as privilege only and not as a right, for the reformation of offenders.

That, any violation/s committed on such Rules and Regulations set forth shall be dealt accordingly and with due process of the law and subject me to the following:

1. Restriction to avail any of the education program of the BuCor; and
2. At any time be ready to suffer the consequences depending on the degree of violation/s committed.
 - a. To render equivalent sanction;
 - b. Cancellation of the additional 15 days GCTA as mandated by the R.A. 10592; or
 - c. Be recommended for dropped/expulsion from roster of student/directive holders of this school.
