SUBJECT: BAC RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) THE AWARD OF CONTRACT FOR THE DRUGS AND MEDICINES, MEDICAL, DENTAL AND LABORATORY SUPPLIES FOR 1ST AND 2ND QUARTER 2024 USE (JANUARY-JUNE 2024)

WHEREAS, Pursuant to the Annual Procurement Plan (APP) 2024 which intends to procure Drugs and Medicines (lot I) Medical, Dental and Laboratory Supplies (lot 2) through Competitive Bidding;

WHEREAS, on March 13, 2024, the Iwahig Prison & Penal Farm through its Bids and Awards Committee posted Invitation to Bid in the electronic board of PHILGEPS with Reference Number 10588622 and in the BuCor Website. Notice of bidding was likewise posted within the premises of Iwahig Prison & Penal Farm, Puerto Princesa City Hall and Provincial Government of Palawan. Letter of Invitation to observers were sent to State Auditor- MIMAROPA, Apostolic Vicariate of Puerto Princesa City, Palawan Chamber of Commerce & Industry, Inc. and Chinese Chamber of Commerce;

WHEREAS, Pre-bid Conference was held on March 01, 2024, 10:00 o;clock in the morning,unfortunately only one prospective bidders attended;

WHEREAS, on March 13, 2024 at 9:00 o'clock in the morning, scheduled date of submission and opening of bids was conducted. Only one prospective bidder Skye Drugstore & Distribution participated.

WHEREAS, after preliminary examination and evaluation of legal and Technical Requirement and Financial Bid, Skye Drugstore & Distribution declared as Single Lowest Calculated Bid (LCB) for lot I and lot II;

WHERAS, the BAC Technical Working Group conducted the Post Qualification to verify, validate and ascertain all statements made and documents submitted by the bidder/s with the Lowest Calculated Bid pursuant to Section 34 of RA 9184 and its Revised IRR;



WHEREAS, On March 25, 2024 Post Qualification Summary Report from the Technical Working Group was received by the Secretariat relative to the post qualification process conducted to Skye Drugstore & Distribution as compliant and responsive to the requirements of bids.



NOW THEREFORE, in view of the foregoing, this Committee, hereby RESOLVES, as it is hereby RESOLVED to:



- a) Declare the bid of Skye Drugstore and Distribution as Single Lowest Calculated and Responsive Bid for Drugs and Medicines (Lot I) and Medical, Dental and Laboratory Supplies (Lot II) and
- b) Recommend to the HOPE the award of contracts to Skye Drugstore and Distribution in the amount of:
