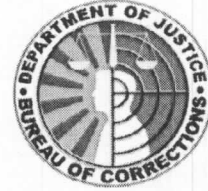







INVITATION TO BID

Expansion of Prison Compound's Perimeter Fence (RDC, Maximum and Medium Compound)

1. The Davao Prison and Penal Farm, through the General Appropriations Act of 2016 intends to apply the sum of TWELVE MILLION PESOS (Php 12,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the **Expansion of Prison Compound's (RDC, Maximum and Minimum Compound) Perimeter Fence** (PR No. 17-01-0018 dated January 06, 2017 approved by the Acting Superintendent -Gerardo F. Padilla, MPA.). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Davao Prison and Penal Farm now invites bids for the **Expansion of Prison Compound's (RDC, Maximum and Minimum Compound) Perimeter Fence**. Completion of the Works is required within 120 calendar days upon issuance of Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, equivalent to at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Davao Prison and Penal Farm and inspect the Bidding Documents at the address given below from 8:00 A.M.-5:00 P.M., Monday-Friday.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of TWENTY-FIVE THOUSAND PESOS (Php 25,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids
6. The Davao Prison and Penal Farm will hold a Pre-Bid Conference on June 14, 2017 at 10:00 a.m. to 12:00 h.n. at the Conference Room, Administrative Building, Davao Prison and Penal Farm, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before June 27, 2017; 10:00 a.m. at DPPF Conference Room, Administrative Building. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The Davao Prison and Penal Farm reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
