## INVITATION TO BID FOR

SUPPLY AND DELIVERY OF VARIOUS MEDICINES FOR DAVAO PRISON AND PENAL FARM  
FOR THE MONTH OF JUNE AND JULY 2019

1. The **Davao Prison and Penal Farm (DPPF)**, through the **General Appropriations Act (GAA) of 2019**, intends to apply the sum of **Three Million Five Hundred Fifteen Thousand Pesos Only (PhP3,515,000.00)**, being the Approved Budget for the Contract (ABC), to payments under the contract for each lot for the **Supply and Delivery of Various Medicines for Davao Prison and Penal Farm for the Month of June and July 2019**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Davao Prison and Penal Farm now invites bids for the **Supply and Delivery of Various Medicines for Davao Prison and Penal Farm for the Month of June and July 2019 at DPPF Conference Room**. Delivery of Goods is required within Seven (7) calendar days upon the issuance of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **DPPF Bids and Awards Committee (BAC) Secretariat** and inspect the Bidding Documents at the address given below during **Monday to Friday from 8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 12, 2019 to July 02, 2019**, 09:00AM from the address below. {insert if necessary: upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (P5,000.00).**}




It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Davao Prison and Penal Farm will hold a **Pre-Bid Conference** on 19 June 2019, 10:00AM at DPPF Conference Room, Admin Bldg., Davao Prison and Penal Farm, Davao del Norte, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **02 July 2019, 9:59AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on July 02, 2019, 10:00AM at the DPPF Conference Room, Admin. Bldg., Davao Prison and Penal Farm, Davao Del Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend. **Late bids shall not be accepted.**

8. The Davao Prison and Penal Farm reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its 2016 Revised IRR, without thereby incurring any liability to the affected bidder or bidders.
