INVITATION TO BID

SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS FOR FABRICATION OF BUNK BEDS FOR PsDL OF MAXIMUM AND MEDIUM SECURITY COMPOUND CY 2018

1. The *Bureau of Corrections*, through the *GAA for CY 2018* intends to apply the sum of *Two Million Pesos (P2,000,000.00)* broken down as follows:

being the Approved Budget for the Contract (ABC) to payments under the contract for the *Supply and Delivery of Construction Materials for Fabrication of Bunk Beds for PsDL of Maximum and Medium Security Compound CY 2018*. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *Bureau of Corrections Bids and Awards Committee (BAC)* now invites bids for *Supply and Delivery of Construction Materials for Fabrication of Bunk Beds for PsDL of Maximum and Medium Security Compound CY 2018*. Delivery of Various Medicines is required *within Five (5) Calendar Days after receipt of the Notice to Proceed by the winning bidder*. Bidders should have completed, within *Twenty-Four (24) Months from* the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

The *Single Largest Completed Contract*, equivalent to at least *Twenty-five percent (25%) of the ABC is Five Hundred Thousand Pesos (P500,000.00)*. The bidder's SLCC similar to the contract to be bid should have been completed within Two (2) years prior to the deadline for the submission and receipt of bids.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *Bureau of Corrections, San Ramon Prison and Penal Farm, Brgy. Talisayan, Zamboanga City* and inspect the Bidding Documents at the address given below during *Mondays-Fridays (9:00am-5:00pm)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *June 18- July 10, 2018* and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount base on the following schedule.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Bureau of Corrections*, will hold a Pre-Bid Conference on *June 27, 2018, 10:00 a.m. at Administration Building, San Ramon Prison and Penal Farm, Brgy. Talisayan Zamboanga City* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *July 10, 2018, 10:00 a.m.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *July 10, 2018, 10:00 a.m. onwards at Administration Building, San Ramon Prison and Penal Farm, Brgy. Talisayan Zamboanga City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. In case of two or more bidders have the lowest calculated responsive bid, the Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer chance as a tie breaker (draw lots) to determine the final LCRB, based on the following procedures:
 - i. In alphabetical order, the bidder shall pick one rolled paper
 - ii. The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder.

9. The *Bureau of Corrections SRPPF-BAC* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
