Being the Approved Budget for the Contract (ABC) to payments under the contract for *REPAIR OF THE SUPERINTENDENT QUARTER'S ROOFING*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Bureau of Corrections Bids and Awards Committee (BAC) now invites bids for *PEPAIR OF THE SUPERINTENDENT QUARTER*. Completion of the Works is required *120 days upon receipt of Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Bureau of Corrections, San Ramon Prison and Penal Farm, Brgy. Talisayan, Zamboanga City* and inspect the Bidding Documents at the address given below during *Mondays- Fridays (8:00am – 5:00pm)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *June 08-29, 2018* and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount base on the following schedule.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Bureau of Corrections, San Ramon Prison and Penal Farm* will hold a Pre-Bid Conference on *June 18, 2018 10:00 a.m.* at *GAD multipurpose hall, San Ramon Prison and Penal Farm, Brgy. Talisayan Zamboanga City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *June 29, 2018, 10:00 a.m.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *June 29, 2018, 10:00 a.m. onwards* at *GAD multipurpose hall., San Ramon Prison and Penal Farm, Brgy. Talisayan Zamboanga City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. In case of two or more bidders have the lowest calculated responsive bid, The Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer chance as a tie breaker (draw lots) to determine the final LCRB, based on the following procedures:
 - In alphabetical order, the bidder shall pick one rolled paper
 - The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder.
9. The *Bureau of Corrections, San Ramon Prison and Penal Farm* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


