This is to describe the BuCor procedures relative to the conduct of faith based reform activity of PDLs.

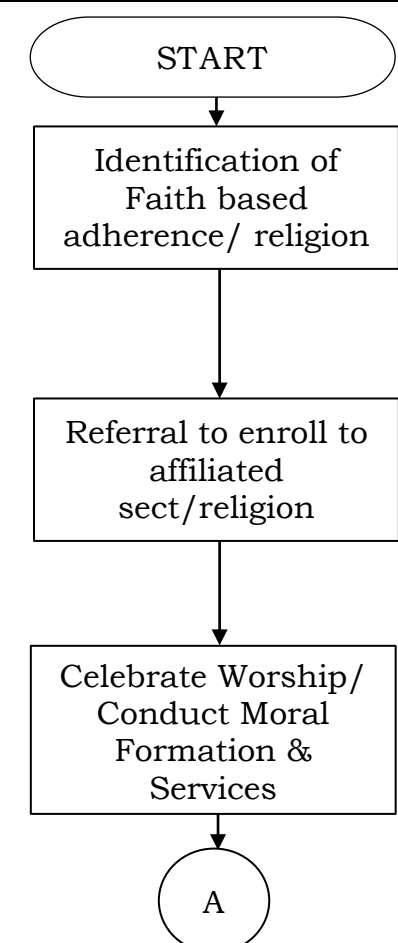

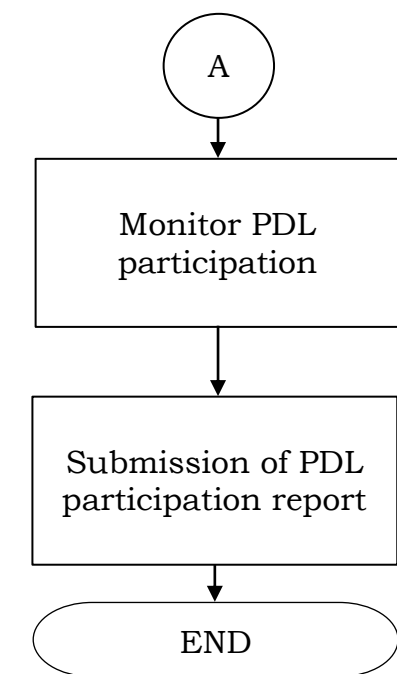
This includes the daily or regular religious activity of PDL based on their religion or sect affiliation like worships, catechism or formation and ministerial/social services.

- 5.4 Gathers PDL attendance of participations and submit accomplishment report (weekly and monthly);
- 5.5 Endorses PDL with attendance to Reformation Coordinator for GCTA requirement.
