II. CALL TO ORDER

The meeting was called to order and presided by the BAC Chairperson CTCSupt. Ma. Lourdes M. Razon, MD at 1:29 in the afternoon.

III. HIGHLIGHTS OF THE PRE-BID CONFERENCE

Dra. Razon acknowledged the presence of the end users and observers from COA.

She also stated that there was scheduled pre-bid conference but was re-set due to the increase on the approved budget of PDL per day from Ten pesos to Fifteen Pesos a day.

Further, she instructed Mr. Catindig to proceed with the discussion of the biding documents.

 Mr. Catindig stated that the procurement of the project can be per line under one lot. Further, he stated that the bid reference number can be viewed on PhilGeps.

Mr. Catindig discussed the following requirements:

- Similar contracts shall refer to Medicines.
- Eligibility requirements;
- Valid and current PhilGeps Certificate of Registration and Membership in accordance with Section 8.5.2 of Revised IRR of RA 9184.
- > Valid and current Department of Trade and Industry (DTI) Registration for Sole Proprietorship and current Cooperative Development Authority (CDA) Registration for cooperative.
- Valid and current Mayor's/Business Permit issued by the city of municipality where the place of business of the prospective bidder is located.
- Valid and current Tax Clearance per Executive Order 398, series of 2005 as finally reviewed and approved by the BIR.

As to the query of the bidder if they could submit an undertaking regarding the submission of the Mayor's permit since the scheduled date given to them by the Municipal is on July 20 of this month, Mr. Catindig stated that they can submit their expired Mayor's Permit together with the proof of payment for renewal provided that on post qualification process they have to present their renewed Valid Mayors Permit. Dra. Razon added that they could put their query into writing so that the BAC could address them accordingly.

Mr. Catindig proceeded to discuss the following;

Statement of prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature. Statement identifying the bidder's Single Largest Completed Contract (SLCC), similar to the contract to be bid within the last two (2) years from the date of submission and receipt of bids equivalent to at least twenty-five percent 25% of the ABC. Certificate of end-user's acceptance (EUA) or Acceptance Report or official receipt (OR) or sales invoice (SI) issued for the contract, if completed, which shall be attached to the statement.

As to the query of the bidder if the attachment of invoice is necessary on the contract, Mr. Catindig stated that no supporting documents is needed on the contract. He further stated that collection receipt is not accepted provided that sales invoice is attached and collection receipt is not considered as primary invoice.

Valid and current Audited Financial Statements, showing, among others, the prospective bidder's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission.

As to the query of the bidder if the Financial Statement should be stamp received by the Bank, Mr. Catindig replied in affirmative.

- Net Financial Contracting Capacity (NFCC) which must be at least equal to the ABC to be bid, and calculated as follows: NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started coinciding with the contract to be bid. Where: The values of the bidder's current assets and current liabilities shall be based on the latest Audited Financial Statements submitted to the BIR, through its Electronic Filing and Payment System (EFPS).
- In Lieu of the NFCC computation the bidder may submits a Committed Line of Credit (CLC) from a Universal or Commercial Bank, it must be at least equal to ten percent (10%) of the ABC to be bid in accordance with Sec 23.4.1.5 of the 2016 Revised IRR of RA 9184.

- The Bidder shall have the option to post Bid Securing Declaration or in any form;
 - Cash or cashier's/manager's check issued by a Universal or Commercial Bank.
 - Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank at least 5% of the ABC.
 - Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security at least 5% of the ABC.
 - Should the bidder opt to submit a Surety Bond as other form of Bid Security it must specify the additional grounds
- Duly Conformed Schedule of Requirements
- Duly Conformed Technical specification
- Duly notarized Omnibus Sworn Statement
- > It must be supported by a Proof of Authority of the designated representative/s for the purposes of
- Duly notarizedSpecial Power of Attorney -For sole proprietorship if owner opts to designate a representative/s;
- Duly notarizedSecretary's Certificate evidencing the authority of the designated representative/s, issued by the corporation, cooperative or the members of the joint venture; Provided that in the case of unincorporated joint venture, each member shall submit a separate Duly notarized Special Power of Attorney and/or Duly NotarizedSecretary's Certificate evidencing the authority of the designated representative/s.
- Packaging and sealing of envelopes, Each Bidder shall submit the following in one (1) big envelope duly labelled containing two sets of envelopes: First envelope must contain four (4) copies of Eligibility and Technical Documents duly marked as "Original Technical Component", "CopyNo.1", "Copy No.2" and "Copy No.3"Second envelope must contain four (4) copies of Financial Bid Form duly marked as "Original Financial Component", "Copy No.1", "Copy No.2" and "Copy No.3".
- All envelopes and folders must be labeled as specify in BDS 20.4.
- Each Bidder shall submit one (1) original and three (3)copies of the first and second components
- The deadline for submission of bids is July 17, 2019-9:00am.
- The address for submission of bids is BAC Conference Room NBP Reservation Muntinlupa City.
- Delivery shall commence within thirty (30) calendar days after the receipt of Notice to Proceed (NTP) and Purchase Order (P.O.) or Contract Agreement

Queries on the Technical Specifications were all duly noted and will be reflected on the Supplemental Bid Bulletin for bidder's information.

As to the query of the bidder on the cost of biding documents, Mr. Catindig stated that the payment will be based on the total ABC to be bid.

As to the query of the bidder on the status of those who bought the bidding documents the last time that it was postponed and yet they already paid for the bid docs, Mr. Catindig stated that they are going to add the difference on the previous amount.

As to the query of the bidder if submission of distributor agreement is necessary, Mr.Catindig stated that certificate of distributorship will do.

As to the query of the bidder if the certificate should be coming directly from the distributor, Mr. Catindig stated that may be submitted purposely to determine the capacity of the supplier to deliver and as proof of availability of medicine supply.

As to the query of the bidder if bid bulletin will be issued after 7 days together with the bid docs, Dr. Razon stated that the biding document is already available. Mr. Catindig discussed the bidding forms. As to the query of the bidder if they can still use the notarized documents submitted before, Mr. Catindig stated that as to the bid securing declaration it could not be possible since the bid reference umber is different and as to the validity of omnibus the BAC will seek legal opinion to the Legal Officer and the bidders will be notified on the matter thru supplemental bid bulletin. He further added that the NFCC is not necessarily notarized. As to the Schedule of Prices, Mr. Catindig stated that the need to indicate Comply or not comply if not He also mentioned the Shelf life of 18 months from the date of acceptance As to the query of the bidder if they can submit a guarantee letter, Ms. Malou Palad replied in affirmative. Mr. Catindig added that LTO and CPR will be submitted during post qualification period. VI. ADJOURNMENT There having no other clarifications to be made, the conference adjourned at around 4:00 P.M.
