II. CALL TO ORDER

The meeting was called to order and presided by the BAC Vice Chairman CCSupt. Richard W. Schwarzkopf, Jr. at 2:00 in the afternoon.

III.HIGHLIGHTS OF THE PRE-BID CONFERENCE

Mr. Catindig mentioned the ABC to be bid of Php 2,199,800.00.

Mr. Catindig stated that the similar contracts shall refer to manufacturer, retailer, supplier, distributor, trader of General Merchandise.

- Valid and current PhilGeps Certificate of Registration and Membership in accordance with Section 8.5.2 of Revised IRR of RA 9184.

Valid and current Securities and Exchange Commission (SEC) Registration for Corporation.

Valid and current Department of Trade and Industry (DTI) Registration for Sole Proprietorship and Valid and current Cooperative Development Authority (CDA) Registration for cooperative.

Valid and current Mayor's/Business Permit issued by the city of municipality where the place of business of the prospective bidder is located.

Valid and current Tax Clearance per Executive Order 398, series of 2005 as finally reviewed and approved by the BIR.

Statement of prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature.

➤ Statement identifying the bidder's Single Largest Completed Contract (SLCC), similar to the contract to be bid within the last two (2) years from the date of submission and receipt of bids equivalent to at least twenty-five percent 25% of the ABC.

Certificateof end-user's acceptance (EUA) or Acceptance Report or official receipt (OR) or sales invoice (SI) issued for the contract, if completed, which shall be attached to the statement.

➤ Valid and current Audited Financial Statements, showing, among others, the prospective bidder's total and current assets and liabilities, stamped "received" by the BIRwhich should not be earlier than two (2) years from the date of bid submission.

Net Financial Contracting Capacity (NFCC) which must be at least equal to the ABC to be bid, and calculated as follows: NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started coinciding with the contract to be bid.

➤ In Lieu of the NFCC computation the bidder may submits a Committed Line of Credit (CLC) from a Universal or Commercial Bank, it must be at least equal to ten percent (10%) of the ABC to be bid.

In case the joint venture is not yet in existence, the submission of a valid JVA shall be within ten (10) calendar days from receipt by the bidder of the notice from the BAC that the bidder is the Lowest Calculated Bid.

> The Bidder shall have the option to post Bid Securing Declaration. Bid Securing 1 2 Declaration must be duly notarized in accordance with the provisions of 2004 Rules on 3 Notarial Practice or any form of Bid Security. 4 Cash or cashier's/manager's check issued by a Universal or Commercial Bank at least 5 2% of the ABC. 6 7 8 > Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or 9 Commercial Bank, if issued by a Foreign Bank. 10 11 > Surety bond callable upon demand issued by a surety or insurance company duly 12 certified by the Insurance Commission as authorized to issue such security at least 5% of 13 14 the ABC. And to include the 14 grounds. 15 Duly Conformed Schedule of Requirements. 16 17 Duly Conformed Technical specification. 18 19 > Duly notarized Omnibus Sworn Statement. It must be supported by a Proof of Authority 20 of the designated representative/s. 21 22 > Duly notarized Special Power of Attorney -For sole proprietorship if owner opts to 23 24 designate a representative/s; 25 > Duly notarized Secretary's Certificate evidencing the authority of the designated 26 representative/s, issued by the corporation, cooperative or the members of the joint 27 venture; 28 29 > Provided that in the case of unincorporated joint venture, each member shall submit a 30 separate Duly notarized Special Power of Attorney and/or Duly Notarized Secretary's 31 32 Certificate evidencing the authority of the designated representative/s. 33 > Packaging and sealing of documents. It must be properly sealed and properly labeled. 34 Each Bidder shall submit the following in one (1) big envelope duly labelled containing 35 two sets of envelopes: First envelope must contain four (4) copies of Eligibility and 36 Technical Documents duly marked as "Original Technical Component", "Copy No.1", 37 "Copy No.2" and "Copy No.3" Second envelope must contain four (4) copies of 38 Financial Bid Form duly marked as "Original Financial Component", "Copy No.1", 39 "Copy No.2" and "Copy No.3" 40 Atty. Santos stated the request that the bidders to submit eligibility with tabbing. 41 Mr. Catindigstated to read ITB clause 20.4 for the labeling of envelope. 42 Mr. Catindig stated that the deadline for submission of bids is on July 08, 2019-2:00pm. He 43 emphasized that late submission will not be accepted. He pointed out that the bid documents may 44 be submitted to the BAC Sec as early as Friday to be safe. 45

Mr. Catindig stated that the Latest Income and Business Tax Return filed thru Electronic Filing

and Payment System (EFPS) 6 months before filing duly validated with the tax payments made

3 4 5	He emphasized that the Schedule of requirements and Delivery shall commence within thirty (30) calendar days after the receipt of Notice to Proceed (NTP) and Purchase Order (P.O.) or Contract Agreement.
6	Technical specifications were discussed.
7	Mr. Catindig reminded the bidders to include Supplemental Bid Bulletins issued by the BAC.
8	He presented the Schedule of prices and reminded the bidders to be mindful of the signatures.
