THIS AGREEMENT made the _____QGTo2 0 2021 20 ____ between;

The NEW BILIBID PRISON (NBP) BUREAU OF CORRECTIONS (BuCor), a government agency organized under and by virtue of the laws of the Republic of the Philippines, under the Department of Justice, with principal office at NBP, Muntinlupa City, herein represented by USEC GERALD Q BANTAG in his capacity as Director General, hereinafter referred to as the ENTITY.

and

IEQUITY TECHNOLOGIES, CORPORATION a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal office at Unit 813, West Tower Philippine Stock Exchange Centre Exchange Road, Ortigas Center Pasig City herein represented by CELERINA C MATEO in his capacity as Account Manager, hereinafter referred to as the SUPPLIER.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., for the Supply and Delivery of Various ICT Software Subscription and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Four Million Eighty Eight Thousand Four Hundred Pesos Only (Php4,088,400.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the General and Special Conditions of the Contract;
 - (c) the Technical Specifications;
 - (d) the Entity's Notification of Award; and
 - (e) The Performance Security
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
