 - h.) All items shall be delivered within **seven (7) calendar days** from the receipt of approved Notice to proceed (NTP).

The BuCor-SPPF shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
