INVITATION TO BID

1. The DAVAO PRISON AND PENAL FARM, through the General Appropriations Act for CY 2019 intends to apply the sum of ONE HUNDRED THIRTY EIGHT MILLION FIVE HUNDRED EIGHTY THREE THOUSAND TWO HUNDRED PESOS (Php 138,583,200.00) being the Approved Budget for the Contract (ABC) to payments under the contract for ONE LOT - FOOD CATERING FOR FOOD SUBSISTENCE OF PDL IN THE DAVAO PRISON AND PENAL FARM AND CIW-MINDANAO from JANUARY 01, 2019 TO DECEMBER 31, 2019 (6,328 PDL x 365 days x Php 60.00 per PDL/day). Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The DAVAO PRISON AND PENAL FARM now invites bids for ONE LOT - FOOD CATERING FOR FOOD SUBSISTENCE OF PDL IN THE DAVAO PRISON AND PENAL FARM AND CIW-MINDANAO from JANUARY 01, 2019 TO DECEMBER 31, 2019 (6,328 PDL x 365 days x Php 60.00 per PDL/day. Bidders should have completed within two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section

II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country, the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from the BAC Secretariat c/o CO3 RAMON P. DELA CRUZ 4. JR and inspect the Bidding Documents at the BAC SECRETARIAT OFFICE, Davao Prison and Penal Farm, B.E. Dujali, Davao del Norte from 8:00 AM to 5:00 PM, Monday to Friday starting November 15, 2018.

5. A complete set of Bidding Documents may be acquired by the interested Bidders on November 15, 2018 from the address below and upon payment of a non-refundable fee for the bidding documents in the amount of

FIFTY THOUSAND PESOS (Php 50,000.00).

The DAVAO PRISON AND PENAL FARM, through its Bids and Awards Committee will hold a Pre-Bid 6. Conference on November 22, 2018 at DPPF Conference Room, Admin. Building, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before December 4, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 4, 2018 at DPPF Conference Room, Admin. Building. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

Bidders must have Single Largest Contract with an amount of at least Fifty Percent (50%) of the ABC within 8. the two (2) year period as stated above with Certificate of Performance Evaluation showing a rating of at least Very Satisfactory Performance issued by bidder's previous clients. However, any queries relative to the contents of the bid documents and the project requirements can only be made by the bidders who purchased the bid documents not later than ten (10) days prior to the deadline of submission of bid documents.

The DAVAO PRISON AND PENAL FARM reserves the right to reject any and all bids, declare a failure of 9. bidding, or award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
