## INVITATION TO BID FOR SUPPLY OF LABOR & MATERIALS FOR THE RENOVATION OF LRP CONFERENCE ROOM

- The Leyte Regional Prison, through the Government of the Philippines (GOP), General Appropriations Act of 2019 intends to apply the sum of Six Hundred Sixty Thousand Four Hundred Three Pesos and 6/100 (₱660,403.06) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply of Labor & Materials for the Renovation of LRP Conference Room with Identification no. BID2019-022. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Leyte Regional Prison now invites bids for Infrastructure Project. Completion of the Works is required within *sixty (60) calendar days*. Bidders should have completed within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from Leyte Regional Prison and inspect the Bidding Documents at the address given below from Monday to Friday from 8:00am to 5:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on *December 7*, 2019@8:00am-5:00pm to *December 16*, 2019@8:00-9:55am from the address below and upon payment of a nonrefundable fee for the Bidding Documents pursuant to the latest guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee of *One Thousand (P1,000.00) Pesos Only* for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat at the address below on or before *December 16*, 2019@9:55am All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *December 16, 2019@10:00am* at Conference Room, Administration Building, Leyte Regional Prison, Brgy. Cagbolo, Abuyog, Leyte. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. The Bids and Awards Committee (BAC) shall use a non discretionary and non discriminatory measure based on sheer luck or chance, which is "DRAW LOTS" in the event that two or more bidders have been post qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final LCRB, based on the following procedures:
  - 1. In alphabetical order, the bidder shall pick one rolled paper.
  - 2. The lucky bidder who would pick the paper with the "CONGRATULATIONS" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.
- 8. The *Leyte Regional Prison* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
