In view of the two (2) failed public biddings, the Bureau of Corrections-Sablayan Prison and Penal Farm (BUCOR-SPPF) Bids and Awards Committee (BAC) invites interested bidders to participate in the negotiation for the *Supply & Delivery of Construction Materials for the Repair of SPPF Prison Facilities' Perimeter Fence for FY 2020 (4 Lots)* with an Approved Budget for the Contract (ABC) of *Seven Hundred Forty Seven Thousand Nine Hundred Eighteen Pesos and Fifty Centavos Only (Php747,918.50)* in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act."

*****Winning bidder/s shall post Performance Security within ten (10) calendar days from receipt of Notice of Award.**
