Use of Kitchen inside Camp The winning bidder may be allowed to use the Kitchen inside the respective camps upon written request to the Director General and upon approval of the same subject to reasonable rent and payment of incidental expenses such as	Fuel Fuel for cooking shall be 40% LPG and 60% rice hull. It shall be borne by the winning bidders subject to usual Prison rules and regulations. Pollution Control Officer Winning Bidder shall employ a Pollution Control Officer to manage the air, water and solid waste produced by the operation. As proof, credential for Pollution Control Officer will be required during post-qualification. Use of Kitchen inside Camp The winning bidder may be allowed to use the Kitchen inside the respective camps upon written request to the Director General and upon approval of the same
		shall install water and electric meter for such purpose to monitor the water and electric consumption of the winning bidder.
