THIS AGREEMENT made the ____ day of _____ 20____ between;

The **NEW BILIBID PRISON (NBP) BUREAU OF CORRECTIONS (BuCor)**, a government agency organized under and by virtue of the laws of the Republic of the Philippines, under the Department of Justice, with principal office at NBP, Muntinlupa City, *herein* represented by **USEC GERALD Q BANTAG** in his capacity as Director General, hereinafter referred to as the **ENTITY**.

and

REVLV SOLUTIONS INC. a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal office at Unit 26M Burgundy Corporate Tower, 252 Sen. Gil Puyat Avenue, Makati City herein represented by **CANNIE EDUARDO** in his capacity as Project Manager, hereinafter referred to as the **SUPPLIER**.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., for the **Acquisition of ICT Software 2021** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Three Million Nine Hundred Ninety Eight Thousand Eight Hundred Pesos Only (Php3,998,800.00)* (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




