THIS AGREEMENT made the \_\_\_\_ day of 7 DFC 7001 between;

The NEW BILIBID PRISON (NBP) BUREAU OF CORRECTIONS (BuCor), a government agency organized under and by virtue of the laws of the Republic of the Philippines, under the Department of Justice, with principal office at NBP, Muntinlupa City, herein represented by USEC GERALD Q BANTAG in his capacity as Director General, hereinafter referred to as the ENTITY.

and

PRONET SYSTEM INTEGRATED NETWORK SOLUTION, INC a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal office at 3<sup>rd</sup> Floor Hollywood Square Building # 33 West Avenue, Quezon City herein represented by KRISTINE BIO in his capacity as Business Development Manager, hereinafter referred to as the SUPPLIER.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., for the Supply, Delivery and Installation of ICT Equipment and Accessories and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Thirteen Million Nine Hundred Thirty Six Thousand Six Hundred Two Pesos Only (Php13,936,602.00) (hereinafter called "the Contract Price").

  - (f) The Performance Security
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
