II. Agenda:

Supply and Delivery of Various Essential BUCOR Vehicles

III. Call to Order:

The meeting for prebid presided by BAC Vice-Chairman started at 0911H. The body was led into prayer by CO1 Lett Carpio.

IV. Discussion Proper

The Vice-Chairman called the BAC Secretariat to do the roll call. The body was informed that five (5) were present and two (2) were absent. Given the pronouncement, a quorum was declared by the Vice-Chairman. Reading of the previous minutes was dispensed.

Upon motion of Mr MANUEL SESCAR, JR duly seconded by CCINSP EDUARDO GOGORZA, the agenda was formally adopted.

The Vice-Chairman greeted the prospective bidders and gave the floor to CTO2 Catindig to discuss the documents needed for the bidding.

CTO2 Catindig informed the members that thru Fund 284 (Income), the BUCOR intends to apply the sum of **Seventy-two Million Pesos Only (₱72,000,000.00)** as the ABC for the said project. Delivery is required within **thirty (30)** calendar days from the date of issuance of Notice to Proceed. Bidders should have completed a contract similar to the Project amounting to at **least fifty percent (50%)** of the ABC within the last four (4) years.

He asked the prospective bidders if they have read the technical specifications in the bid documents. One of the bidders said that they cannot download the documents in the PhilGeps. CTO2 Catindig instructed the BACSEC to provide each of the prospective bidders, copies of the said document and to verify whether the documents are downloadable or not.

CTO2 Catindig presented the legal and technical documents to be submitted by the bidders that shall be put inside a sealed envelope:

- PhilGeps Platinum
- SEC Registration
- Mayor's Business Permit
- Tax Clearance
- Audited Financial Statement
- On-going Contracts
- Single Largest Completed Contracts
- Bid Security/Bid Securing Declaration (notarized)
- Schedule of Requirements
- Technical Specifications
- Omnibus Sworn Statement (notarized)
- Authority of Signatory/ Secretary Certificate (notarized)

Net Financial Contracting Capacity

Another envelope for the Financial documents shall include:

- Duly accomplished Financial Bid Form
- Price Schedule(s)

Bidders are required to submit only one (1) copy of both the envelopes and will be put together in one sealed mother envelope and will be submitted on or before 0900H of the date of Opening of Bids.

CTO2 Catindig continued with the presentation of the technical specifications and schedule of delivery of the following items:

The duration of the project is 30 calendar days. He presented the pictures of the different units. He also informed the members and bidders of the possibilities of having supplemental bid bulletin. Bidders are also required to prepare their Certificate of Availability of Stocks.

The Vice-Chairman told the bidders that after the prebid, other questions and concerns must be put into writing, adressed to the BAC. BAC will answer through Supplemental Bid Bulletin.

CCINSP EDUARDO P GOGORZA asked if the project is for one (1) Lot only. CTO2 Catindig answered it is just one (1) lot.

CTO2 Catindig informed the members and bidders of the following schedule:

- Submission of bids will be on or before 19 October 2022 0900H
- Opening of bids is on 19 October 2022 0900H

After the presentation, CTO2 Catindig asked the bidders if they have questions about the project. The bidders said that they don't have any questions and will just send letter in any case they have other concerns. With that, the Vice-Chairman gave his gratitude to all the prospective bidders that attended the meeting and politely instructed them to leave the venue.
