**INVITATION TO BID FOR
GARBAGE COLLECTION AND DISPOSAL FOR NBP 2023**

1. The **Bureau of Corrections**, through the **National Expenditure Program (NEP) of 2023** intends to apply the sum of **Eleven Million Nine Hundred Ninety Nine Thousand Pesos Only (P11,999,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Garbage Collection and Disposal for NBP 2023** with **Identification no. 017**. Bids received in excess of the ABC shall be automatically rejected at bid opening
2. The **Bureau of Corrections**, now invites bids for the above Procurement Project. Contract shall commence from the approval of Contract Agreement and issuance of Notice to Proceed up to December 31, 2023 or upon reaching the total quantity of garbage to be collected whichever comes first. Bidders should have completed, within the last four (4) years from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Bureau of Corrections** and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00am to 5:00pm.

A complete set of Bidding Documents may be acquired by interested Bidders on NOVEMBER 29, 2022 from the given address and website(s) below. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity bucor.gov.ph, provided that Bidders shall pay the applicable fee in the amount of **ten thousand (P10,000.00) pesos only** for the Bidding Documents not later than the submission of their bids. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or by facsimile.

5. The **Bureau of Corrections** will hold a Pre-Bid Conference on DECEMBER 06, 2022 ^{9:00 AM} BAC Conference Room NBP Reservation Muntinlupa City, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before DECEMBER 20, 2022 Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on DECEMBER 20, 2022 9:00 AM at the BAC Conference Room NBP Reservation Muntinlupa City, Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
9. The **Bureau of Corrections** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
