INVITATION TO BID FOR

Supply and Delivery of Various Construction Materials for Fabrication of Bunk Beds for PDL to be Confined at Davao Prison and Penal Farm

- 1. The Bureau of Corrections Davao Prison and Penal Farm, through the NHQ-INCOME FUND for FY 2023 intends to apply the sum of Philippine Pesos Ten Million Three Hundred Twenty-Nine Thousand Nine Hundred Only (PhP 10,329,900.00) being the ABC to payments under the contract for Supply and Delivery of Various Construction Materials for Fabrication of Bunk Beds for PDL to be Confined at Davao Prison and Penal Farm with approved Purchase Request (PR) No. 2023-01-0055-A & 2023-01-0123-A. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Davao Prison and Penal Farm now invites bids for the above Procurement Project. Delivery of the Goods is required within five (5) days from the Receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
 - Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least twenty-five percent (25%) of the ABC which is Philippine Peso Two Million Five Hundred Eighty-Two Thousand Four Hundred Seventy-Five Only (PhP 2,582,475.00).
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from BAC Office of Davao Prison and Penal Farm, B.E Dujali, Davao del Norte and inspect the Bidding Documents at the address given below during Mondays-Fridays from 8:00 AM 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on February 21, 2023 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Philippine Peso Twenty-Five Thousand Only (PhP 25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

- 6. The **Davao Prison and Penal Farm** will hold a Pre-Bid Conference¹ on March 01, 2023, 2:00 PM at DPPF Conference Room, Administrative Building, B.E. Dujali, Davao del Norte and/or through video conferencing via google meet, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before MARCH 13, 2023, 01:45 PM. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a **bid security** in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on MARCH 13, 2023, 02:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
