The NEW BILIBID PRISON (NBP) BUREAU OF CORRECTIONS (BuCor), a government agency organized under and by virtue of the laws of the Republic of the Philippines, under the Department of Justice, with principal office at NBP, Muntinlupa City, herein represented by GENERAL GREGORIO PIO P. CATAPANG JR., AFP (RET.), CESE in his capacity as Acting Director General, hereinafter referred to as the ENTITY.

and

JMJD TECHNOLOGIES CORPORATION a private corporation duly organized and existing under the laws of the Republic of the Philippines, with principal office at 1156A Cristobal St., Sampaloc Manila herein represented by PERFECTO C. - 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
