## ***Section I. Invitation to Bid***

### ***SUPPLY & DELIVERY OF FUEL FOR SPPF VEHICLES, MACHINERIES & EQUIPMENT FOR THE MONTH OF MARCH 2023 – 1 LOT***

1. The ***Sablayan Prison & Penal Farm***, through its ***General Appropriations Act of 2023*** in the amount of ***Three Hundred Forty Eight Thousand Seven Hundred Fifty Only (Php. 384,750.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***“Supply & Delivery of Fuel for SPPF Vehicles, Machinerics & Equipment for the Month of March 2023 – 1 Lot”*** with ***Bid Reference No. BIDSPPF2023-010***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The ***Sablayan Prison & Penal Farm*** now invites bids for the above Procurement Project. Delivery of the Goods is required within Thirty (30) Calendar Days from the receipt of Notice to Proceed (NTP). Bidder should have completed from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary ***“pass/fail”*** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from ***Sablayan Prison & Penal Farm, BAC Office*** and inspect the Bidding Documents at the address given below during ***Weekdays (Monday to Friday) 8:00AM to 5:00PM***.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***February 7, 2023 at 8:00 am to 10:00am of February 14, 2023*** from the given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount

of Php 500.00. The Procuring Entity requires the bidder to present proof of payment.

6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before *10:00 AM of February 14, 2023*. Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on *February 14, 2023*, at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
9. The *Sablayan Prison and Penal Farm* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
