The required number of rounds for the testing	<p>The required number of rounds specified under Section 4 of the Special Conditions of the Contract (SCC) is amended as follows:</p> <ul style="list-style-type: none">One Hundred (100) rounds for Caliber 9mm, One Hundred (100) rounds for Caliber 5.56mm, One Hundred (100) rounds for Caliber 45 full metal jackets, One Hundred (100) rounds for Caliber 40 full metal jackets, One Hundred (100) rounds for Gauge 12 and 100 rounds for Caliber 5.56mm (Blank Ammunitions) shall be provided by the supplier to be tested by the Bucor Inspection and Acceptance Committee (BIAC), COA Representative and End-User prior to final acceptance.
