**INVITATION TO BID FOR
SUPPLY AND DELIVERY OF MATERIALS FOR THE
CONSTRUCTION OF WARNING FENCE IN BLDG. 1 AND 2
OF DPPF EXPANSION AREA**

1. The *Bureau of Corrections – Davao Prison and Penal Farm*, through *NHQ-INCOME FUND 284 for FY 2023* intends to apply the sum of *Philippine Peso Six Million Eight Hundred Nine Thousand Two Hundred Only (PhP 6,809,200.00)* being the ABC to payments under the contract for *Supply and Delivery of Materials for the installation of Warning Fence in Bldg. 1 and 2 of DPPF Expansion Area with PR No.2023-0452*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bureau of Corrections – Davao Prison and Penal Farm* now invites bids for the above Procurement Project. Delivery of the Goods is required *within 20 days from the receipt of Notice to Proceed*. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least twenty-five percent (25%) of the ABC which is Philippine Peso One Million Seven Hundred Two Thousand Three Hundred Only (PhP 1,702,300.00).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *BAC Office of Davao Prison and Penal Farm, B.E Dujali, Davao del Norte* and inspect the Bidding Documents at the address given below during *Mondays-Fridays from 8:00 AM – 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *April 13, 2023* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Philippine Peso Ten Thousand Only (PhP 10,000.00)*.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees *presented in person*.

6. The **Davao Prison and Penal Farm** will hold a **Pre-Bid Conference**¹ on **April 21, 2023 2:00 PM** at **DPPF Conference Room, Administrative Building, B.E. Dujali, Davao del Norte** and/or through video conferencing *via google meet*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission** at the office address indicated below on or before **May 03, 2023, 01:45 PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. **Bid opening** shall be on **May 03, 2023, 02:00 PM**. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
