**INVITATION TO BID FOR
 SUPPLY AND DELIVERY OF MEDICINES AND SUPPLEMENTS (Lot 1)
 and SUPPLY AND DELIVERY OF MEDICAL SUPPLIES AND
 EQUIPMENT (Lot 2) FOR DPPF AND CIW-MINDANAO FY 2023**

- The *Bureau of Corrections- Davao Prison and Penal Farm*, through the *General Appropriations Act (GAA) FY 2023* intends to apply the sum of *Philippine Peso Thirty-Five Million Six Thousand Three Hundred Thirty-Six and 60/100 Only (PhP 35,006,336.60)* being the ABC to payments under the contract for Project, *Supply and Delivery of Medicine and Supplements (Lot 1) and Supply and delivery of Medical Supplies and Equipment (Lot 2) for DPPF and CIW-Mindanao FY 2023*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The *Bureau of Corrections- Davao Prison and Penal Farm* now invites bids for the above Procurement Project. *Delivery of the Goods is required as stated in Section VI. Schedule of Requirements*. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the **DPPF Bids and Awards Committee Office** and inspect the Bidding Documents at the address given below during **Monday to Friday from 8:00 AM to 5:00 PM**.

9. **Bid opening** shall be on **July 19, 2023 at 10:00 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
