Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).	Item No. 2. The <i>BuCor</i> now invites bids for the above Procurement Project. Delivery of the Goods is required within Fifteen (15) calendar days from the receipt of the Notice to Proceed . Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project equivalent to twenty-five percent. (25%) of the ABC . The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

D. Additional Technical Specs, Operational Training and Warranty

- a. 3 way input (**left, right and center**) for oxygen gas tank for protective gas mask;
- b. Drone Flight operational training and 12 months warranty upon full acceptance by the end-user
- c. Night Vision Goggles (NVG) operational training and 60 months warranty upon full acceptance by the end-user


