2. Contract Period: *calendar days*
3. Location Site: *Davao Prison and Penal Farm, B.E Duijali, Davao del Norte*
4. Payment Term: *Payment shall be made after the complete delivery and installation.*
5. Price proposal must be valid for the period of **thirty (30) calendar days** from the date of submission.
6. Price proposal to be denominated in **Philippine Peso (PhP)**, include all taxes and duties and/or levies payable.
7. Proposals exceeding the ABC per lot shall be automatically rejected.
8. The **award of the contract** shall be made to the lowest calculated and responsive proposal per lot, which complies with the minimum technical specifications and other terms and conditions stated herein.
