1. Bidders shall provide the **correct and accurate information** required in this form.
2. Contract Period: **30 calendar days**
3. Payment Term: **Payment shall be made after the complete delivery of items and/or services.**
4. Price proposal must be valid for the period of **thirty (30) calendar days** from the date of submission.
5. Price proposal to be denominated in **Philippine Peso (PhP)**, include all taxes and duties and/or levies payable.
6. Proposals exceeding the ABC per lot shall be automatically rejected.
7. The **award of the contract** shall be made to the lowest calculated and responsive proposal per lot, which complies with the minimum technical specifications and other terms and conditions stated herein.
