TERMS AND CONDITIONS

- 1. Bidders shall provide the correct and accurate information required in this form.
- 2. Contract Period: 15 calendar days
- 3. Payment Term: Payment shall be made after the complete delivery of items and/or services.
- 4. Price proposal must be valid for the period of thirty (30) calendar days from the date of submission.
- 5. Price proposal to be denominated in Philippine Peso (PhP), include all taxes and duties and/or levies payable.
- 6. Proposals exceeding the ABC per lot shall be automatically rejected.
- 7. The **award of the contract** shall be made to the lowest calculated and responsive proposal per lot, which complies with the minimum technical specifications and other terms and conditions stated herein.
- 8. Any interlineations, erasures, or overwriting shall be valid only if they are signed or initiated by the bidder or any of his/her duly authorized representative/s.
- 9. Liquidated damages equivalent to one-tenth of one percent (0.001%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. DPPF shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open.
