INVITATION FOR NEGOTIATED PROCUREMENT FOR TWO-FAILED BIDDINGS

SUPPLY AND DELIVERY OF FEEDS

1. The Iwahig Prison and Penal Farm (IPPF), through Fund 284 intends to procure feeds for Aqua Section with an Approved Budget for the Contract (ABC) of Seven hundred seventy-four thousand nine hundred pesos (Php774,900.00).
2. The *IPPF* now invites technically, legally and financially capable suppliers or the said project.
3. The procurement procedure for this requirement is Negotiated Procurement for Two-Failed Biddings pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. The Bids and Awards Committee will select supplier with best final offer and meet the required minimum technical specifications.
5. Interested prospective Bidders may obtain further information from *IPPF-BAC Secretariat* and inspect the Bidding Documents at the address given below from September 20, 2024 to September 27, 2024, Monday to Friday (8:00 to 5:00 P.M.).
6. The BAC will hold the Negotiation Meeting on September 27, 2024 at 10:00 o'clock in the morning at the BAC Office, Central Sub-Colony, Puerto Princesa City.
7. Two (2) copies of the proposals (one original and one certified photocopy) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at BAC Office on or before 10:00 AM of September 27, 2024. Late submission shall not be accepted.
8. Interested bidders shall submit the following documents in sealed, labeled and marked envelopes as "Negotiated Procurement for Two-Failed Biddings", with the title of the project, name of the bidder, address with contact number address to the BAC.

A. Eligibility and Technical Documents

- a. Valid PhilGEPS Registration Certificate (Platinum Membership)
- b. Statement of bidder's Single Largest Contract (SLCC) similar to the contract to be bid. Which shall be completed within the last three years prior to the date of the negotiation.
- c. Bid Security in any of the following form as prescribed under 2016 revised IRR of RA 9184:
 - i. in case of Cash, Manager's Check, Bank Guarantee (2% of the ABC)

ii. In case of Surety Bond, submit a certification issued by the Insurance Commission or Original Copy of Securing Bid Declaration (5% of the ABC

iii. Bid Securing Declaration

d. Conformity with the Schedule of Requirements

e. Conformity with the Technical Specifications

f. Special Conditions of the Contract shall form part of the contract. Other conditions of the contracts shall be governed by the implementation of the rules and regulations of RA 9184.

g. Notarized Omnibus Sworn Statement (OSS) supported with Notarized Secretary's Certificate in case of corporation or cooperative; in case of partnership or single proprietorship, the bidder shall submit Special Power of Attorney executed by the partners or single proprietorship whichever is applicable.

In case of Joint Venture, Special Power of Attorney shall be submitted by all members of the joint venture giving full power and authority to its offer to sign the OSS and do acts to represent the Bidder.

h. If applicable, a duly signed Joint Venture Agreement (JVA), in case it is already in existence or duly notarized statement from all the joint partners stating that will enter into and abide by the provisions of the JVA in the instance that the bid is successful.

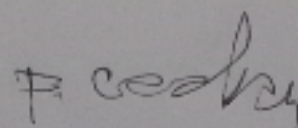
