## INVITATION TO BID

### SUPPLY AND DELIVERY OF DIESEL FOR IPPF HEAVY EQUIPMENT (REBID)

1. The Iwahig Prison and Penal Farm (IPPF), through the Fund 284 intends to apply the sum of One Million Two Hundred Forty Thousand Pesos (Php1,240,000.00) being the ABC to payments for diesel for IPPF heavy equipment.
2. The IPPF now invites bids for the above Procurement Project. Delivery of the Goods is required *within Fifteen (15) calendar days from the receipt of the Notice to Proceed*. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *IPPF-BAC Secretariat* and inspect the Bidding Documents at the address given below during Mondays to Fridays (8:00 to 5:00 P.M.).
5. A complete set of Bidding Documents may be acquired by interested Bidders on **16 December 2024 (8:00 A.M. to 5:00 P.M. not available on Saturdays, Sundays and Holidays)** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *to be presented in person at the IPPF-BAC Secretariat*.
6. The IPPF will hold a Pre-Bid Conference<sup>1</sup> on **23 December 2024 (1:00 PM)** at *IPPF, New Conference Room* which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **06 January 2025 (1:00 P.M.)** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *IPPF* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
