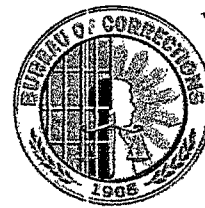

Anent the Pre-bid Conference held on 06 January 2025 for the above-cited procurement, please be informed of the following amendments:

All amendments are indicated in **red**.

A. Section II. Instruction to Bidders

| <p>Item No. 5. Eligible Bidders 5.2 The Bidder must have an experience of having completed a Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted, if necessary, by the Bidder to current prices using the PSA's CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184.</p> <p>A contract is considered to be "similar" to the contract to be bid if it has the major categories of work stated in the BDS.</p> | <p>In support to the Statement of Single Largest Completed Contract (SLCC) requirement that is similar to the Project which shall be submitted by the prospective bidder/supplier, a valid certification from PSA will be accepted in consideration to the value adjusted to current prices using the PSA Consumer Price Indices (CPI) to meet the required Fifty percent (50%) of the Approved Budget for the Contract (ABC) to be bid, in case the SLCC computation will not suffice the requirement. (pursuant to Sec. 23.4.2.4 of the Revised IRR of R.A. 9184).</p> |
| <p>Item No. 16 Sealing and Marking of Bids</p> <p>Each Bidder shall submit one copy of the first and second components of its Bid. The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification. If the Procuring Entity allows the submission of bids through online submission to the given website or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.</p> | <p>The BAC reiterated that the prospective bidder/s shall submit Two (2) sealed envelopes and shall be placed inside One (1) sealed Mother envelope, properly marked and sealed. The aforementioned procurement is a 2-stage Competitive Bidding, whereby the financial bid shall be opened once the prospective bidder/s will be rated "PASSED" for the opening of the 1st Envelope (Legal and Technical documents) through the certification by the Design and Build Committee.</p> |
