



**INVITATION TO BID FOR
 Procurement of Construction Materials on Per Lot Basis for
 Various Projects at Davao Prison and Penal Farm and CIW-
 Mindanao**

1. The *Bureau of Corrections – Davao Prison and Penal Farm*, through the *GAA FY 2025* intends to apply the sum of:

Lot 1	Repair and Extension of Isolation Building for RDC Dormitory at CIW-Mindanao	Php 898,710.00
Lot 2	Improvement of 2 Units Room at DPPF Guest House	Php 667,680.00

being the ABC to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *Bureau of Corrections – Davao Prison and Penal Farm* now invites bids for the above Procurement Project. Delivery of the Goods is required as specified in Section VI Schedule of Requirements. Bidders should have completed, within *two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *BAC Office of Davao Prison and Penal Farm, B.E Dujali, Davao del Norte* and inspect the Bidding Documents at the address given below during *Mondays-Fridays from 8:00 AM – 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *March 25, 2025, Mondays-Fridays from 09:00 AM – 05:00 PM* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *presented in person*.
