Food and Related Technical Specifications Item No. 3: Inventory</p> <p>The winning Bidder shall at any time, have at least three (3) weeks inventory stock of NON- PERISHABLE ITEMS and at least one (1) week inventory stock of PERISHABLE ITEMS as guarantee against any eventuality or unforeseen event that may affect the availability of food subsistence of PDL.</p>

D. Section IV. General Conditions of the Contract

Additional Provision (to be included in the Terms of Reference):

Clause # 7 – Force Majeure

7.1 The caterer shall prepare and submit a Business Continuity and Emergency Preparedness Plan (BCEPP) to ensure continuous food supply during emergencies (e.g., earthquake, fire, flood, pandemic, power interruption, civil disturbance, etc.). The plan should include:

- **Alternative food preparation sites**
- **Backup suppliers of raw materials**
- **Emergency delivery routes and contact points**
- **Coordination procedures with BuCor and local disaster response units**

Pursuant to Section 22.5 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, this Supplemental/Bid Bulletin is issued for the information and guidance of all prospective bidders and shall form an integral part of the Bidding Documents issued for said the project.
