- 2) The Davao Prison and Penal Farm now invites bids for the Supply and Delivery of Construction Materials for Various Projects of General Services Section on Per Lot Basis<sup>5</sup>. Delivery of the Goods is required within **Thirty (30) calendar days upon issuance of Purchase Order**. Bidders should have completed, at least **Two (2) years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.
- i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or






