

WHEREAS, the Bureau of Corrections, Davao Prison and Penal Farm Bids and Awards Committee (DPPF-BAC), under Purchase Request No. 2026-02-0021, adopted Section 34 Small Value Procurement as prescribed under Rule IV – Modes of Procurement of the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 12009, other known as the “New Government Procurement Act” for the Supply and Delivery of Photocopier Toners with Free Use of Photocopier Machines which has an Approved Budget for the Contract (ABC) amounting to **Philippine Peso Three Hundred Thirty-Four Thousand Two Hundred Fifty Only (P 334,250.00)**;

WHEREAS, on **February 13, 2026**, the BAC posted its Request for Quotation at the Bulletin Board of the DPPF Administrative Office, BuCor Website and on PhilGEPS Website;

WHEREAS, on **February 17, 2026** the scheduled Opening of Quotations/Bids, **three (3)** prospective bidders/suppliers submitted their price quotation/proposal using the prescribed RFQ form. The BAC with the assistance of its Technical Working Group (TWG), evaluated the submitted quotations/proposals taking into consideration the completeness of the quotation, arithmetical corrections and the bidders’ compliance with the required documents;

WHEREAS, the BAC, together with its **Technical Working Group (TWG)**, conducted post-evaluation, determining the following result:

WHEREAS, the bid of **Photodynamic Photocopier Machine, Supplies and Services** amounting to **Philippine Peso Three Hundred Thirty-Four Thousand Two Hundred Fifty Only (P 334,250.00)**, was found to be fully compliant with the technical requirements and other conditions specified in the Request for Quotation;
