However, on Front and Rear Elevation plans shows that front parapet wall and exterior wall shall be Stucco Finish.</p>	<p>Per Design and Build Committee, for exterior painting: Disregard other paint finishes and consider <b>WHITE ELASTOMERIC PAINT.</b></p>
<p><b>2. Masonry Works Reinforcement</b></p> <p>Clarification on the applicable reinforcement diameter and spacing for masonry works: On Structural Plan (S-3) Wall footing Details shows that the bar spacing for CHB #6 are: for Vertical Bar indicates 12mm spaced @600mm and Horizontal bar 10mm spaced @600mm. However, on S-1 Construction Notes Item C.4 show below details.</p> <p>a. CHB 6: 10mm @400mm (vertical), 10mm @600mm (horizontal).</p>	<p>Per Design and Build Committee, please consider the <b>CONSTRUCTION NOTES.</b></p>
